#### WOIP Mapping Grant-

o Completed up to date reporting on the project including grant finances. Provided report to DEC o Submitted a "no cost" time extension to DEC. The grant originally was supposed to be completed December 31, 2022 but we know we will not make that deadline. I have asked for an extension to

December 31, 2024.

- o Chemung County Sewer District- Maple Street storm sewer that was previously clogged was opened with the County's ram jetter truck and televised.
- Working with GST BOCES regarding some of their existing driveway culvert pipes that they are replacing.
- Wrote two newsletter articles for the Soil and Water Annual Newsletter. One on the BOCES E&S training/field day and one on the work on the WQIP mapping project.
- Storm Sewershed GIS Mapping Updates- at a stand still. GIS computer has been temporarily repaired but with a very slow connection. I am actively rebuilding our GIS layers onto the desktop so that we do not have to deal with a slow connection until the repair is made to the fiber network. This sewershed work needs to be completed by the end of the month.
- Attended ZOOM meeting on DRAFT drainage survey being put out to municipal highway departments by Cornell Local Roads.
- Water Sampling with Gene Stow for the Chemung County WQCC
- Outfall inspections-bring Nikole Watts up to speed on how to do the inspections-Jessica needs to get some jobs off her list of work
- Working on the future Plans for the Stormwater Team. Generating ideas, having discussions, etc. in preparation for our Coalition meeting on January 19<sup>th</sup>, 2022

  - o Chad Kehoe with NYS DEC called regarding complaint about recycling facility.
  - o Discussion with Code Department and Marc Maser regarding subdivision that was never approved or permitted. Consultant needed to know what version of the standards they needed to follow.
- Town of Southport
  - o Drone photos for Code Department of property behind Tops Friendly Markets
- Town of Veteran
  - o Reviewed and approved Hulett Well Reclamation SWPPP.
- · Chemung County
  - o Drone photos of Middle Road demonstrating Flex Mat and no flex mat (see photos below).
  - o Set bench mark at Lake Street Sewer Plant for grading work the SWCD will be doing
- Elmira Corning Regional Airport
  - o Fuel farm secondary containment is connected to the County sanitary sewer. The airport will need to disconnect this line and dispose of the water properly. I am trying to get guidance from NYS DEC as to what the proper disposal method is. Tara Blum, Regional Water Engineer followed up with me that they are still looking into what should be done with this water. All Regions in NYS seem to handle it differently so she is trying to be diligent about her research and consideration.
